Chief Van der Veen stated that he does not want to proceed with an engine purchase until the exterior project for Britton Loop Station 12 is underway and no hidden costs are discovered.

**Britton Loop Station 12 Exterior Project:** Chief Van der Veen announced that the district is waiting on permit approval from the Whatcom County Planning Commission before the project can proceed.

There was discussion regarding informing constituents about the upcoming project through social media, sandwich boards, and a press release. Construction hours will also be posted.
