Regular Board of Fire Commissioners Meeting**

**CALL TO ORDER**

Chairman Cooley called the regular Whatcom County Fire District #4 Board of Fire Commissioners meeting for February 10, 2025, to order at 12:01 p.m.

**ROLL CALL**

Attendees: Chairman Steve Cooley; Vice-Chairman Tim Johnson; Fire Commissioner Mark Lann; Fire Chief Jason Van der Veen.

District 21 Chairman Bruce Ansell joined the meeting at 12:04 p.m.

With the rescission of Proclamation 20-28, the district continues to do its best to provide accommodations to the public. A direct link allowing the public to participate in the meeting during the public comment section was included on the meeting agenda and posted on the District's website.

**MOTION:** Commissioner Lann moved to approve the Consent Agenda as presented. The motion was seconded by Vice-Chairman Johnson and approved 3-0.

**UNFINISHED BUSINESS**

**Britton Rd/Northern Heights Annexation:** Chief Van der Veen provided information about the proposed annexation of the Britton Rd/Northern Heights area, which includes the Britton Loop Station 12 property. The Boundary Review Board is reviewing the proposal and has not approved or rejected it at this time.

The complete Notice of Intention for the proposed annexation of approximately 146 acres into the City of Bellingham was received by the Whatcom County Boundary Review Board. After being reviewed for completeness of the materials and accuracy of the legal description of the affected property, it was accepted for filing on January 22, 2025.

Department heads within the City of Bellingham provided written information regarding the impacts and potential ways to mitigate those impacts.

In this written impact statement, Bellingham Fire Department Chief Hewett discussed the 1997 interlocal agreement, which could trigger the sixty percent threshold. The agreement is vague, making it difficult to know how to proceed. Chairman Cooley would like to investigate the best way to determine the sixty percent threshold before the City Council makes the annexation decision without burdening the administrative staff. Chairman Cooley and Chief Van der Veen plan to discuss the topic with Attorney Eric Quinn, which may include correspondence to the City Council.


Chairman Cooley stated that the other option is to request a contract with the City for fire and EMS services.

District 21 Chair Ansell noted that if the annexation is approved, more resources will be required to expand the Bellingham Fire Department, which they may not have. The loss of District 4 would affect District 21's budget by twenty-five percent, specifically the administrative department, which already has minimal staffing. District 21 Chair Ansell expressed his desire to continue providing fire and EMS services to District 4, at least until District 21 can pass their levy.

Chief Van der Veen stated that it makes more sense for the districts to remain together. The City does not have tenders or brush trucks required to serve the rural areas of the proposed annexation.

In addition, if the annexation goes through and after the City's three-year obligation to provide the District with the lost revenue, the remaining property owners must make up the difference. More investigation will be necessary to determine the value of the annexed property before any decision is considered.

The Board stressed that their duty is to its employees and customers. Their goal is to remain fiscally responsible and to govern. Unless it proves to be a huge advantage, the District is amenable to continue to contract for services with District 21. Bellingham Fire Chief Hewett may be available to attend the March meeting or a special meeting for further discussion if necessary.


